**Food Booths** ----- \$100.00 (per 10X10 space)  
**WE WILL ONLY BE ACCEPTING A LIMITED NUMBER OF FOOD BOOTHS THIS YEAR. PLEASE CALL BEFORE MAILING FORMS TO ENSURE AVAILABILITY.**  
Church or Non –Profit Food Booths (Must Be Approved) ----- \$75.00 (per 10X10space)  
**Vendor Booths**----- \$30.00 (per 10X10 space)  
**Electricity** (for all spaces rented) ----- 110 service \$10.00 ----- 220 service \$15.00

- Booth spaces are **10X10**. When renting spaces please be sure to measure tongues, awnings, etc. **You will not be allowed to set up if you do not have enough space rented. NO EXCEPTIONS!!**
- Each vendor is responsible for their own tables, chairs, tents, awnings, water hoses, and ALL electric cords. **Please be sure to have plenty of cord available as our electric locations are limited.** All extension cords must be heavy duty cords.
- Liability insurance is required for food booths preparing food within their spaces.
- Booth spaces are assigned. Locations will be given at the Gazebo area on the town square on Friday, March 17th starting at 5:30pm and Saturday, March 18th at 7:00am. **NO BOOTH SPACES ARE GUARANTEED.** There will be **ABSOLUTELY NO SET UP BEFORE 5:30 P.M., FRIDAY, MARCH 17th.** All booths must be set up and ready for business by 8:30A.M. festival day. **Tear down will be at 5:30 (NO EXCEPTIONS).**
- We do not offer refunds in the event of inclement weather. Refunds are only given in the event of an emergency and must be approved by Louisiana Redbud Association committee.
- When filling out booth forms please list items to be sold. Please understand we do sometimes have duplicate vendors.
- NO type of animals are allowed to be sold. Knives, swords, air soft guns, etc., are **NOT TO BE SOLD TO MINORS**. If caught doing so you will be asked to leave by Law Enforcement.
- You will be responsible for paying sales tax (State 4.45%, Parish 5.35%). Please pay all taxes by check. You will receive a tax packet at check in. It will be your responsibility to mail them in if they are not picked up by an authorized tax collector. We have **NO CONTROL** over taxes or problems associated with tax collection.
